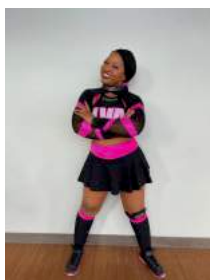

### RULES & REGULATIONS

- Challenging the coach or person in charge, by a team member or parent will be automatic dismissal.
- Each team member must follow all rules given by coach or person in charge at all times.
- Bullying from a team member or a parent will not be tolerated and will be subject to dismissal.
- No unsupervised tumbling or stunting before, during or after practice on the premises.
- No smoking, vaping, drinking alcohol or drug use on the premises.
- Lying, stealing, foul language or any other negative form of behavior is grounds for dismissal.
- Team members need to adhere to dress code when coming to practice;
  - o Hair must be pulled back from face and tied up with a bow
  - o NO JEWELRY
  - o No bulky hair clips or headbands
- Do not bring NEGATIVITY to practice. Negative comments about our team, members, coaches or parents will not be tolerated and may be subject to suspension or dismissal.
- Each Cheerleader and Parent must realize the manner in which they conduct themselves while representing “LAS VEGAS ALL STARS,” directly reflects on the entire squad and coaches.
  - While uniform or team colors are worn, you are representing Las Vegas All Stars, act appropriately.
  - Social Media posts also represent LVA, please post accordingly.

Please understand these rules are put in place for the safety of the athletes, and failure to adhere to them will lead to the athlete being dismissed until the violation is remedied to the coaches' satisfaction.

### PRACTICES

Practice is a DROP OFF and PICK UP situation only. Parents are not allowed to sit in during practices.

Please try your best to plan all personal events and extra-curricular activities outside of the practice schedule. Missing practice due to a conflicting practice or rehearsal for another commitment is unacceptable unless prior approval from the coach.

In any instance that practice must be missed, you must notify the coaching staff at least 7 days prior to missed practice by filling out an absence request form. This helps allow the coaching staff to place athletes on accurate teams and performance spots in a routine.

Absence Request forms are available at the gym and online under the “Forms” page at [www.LVAcheer.com](http://www.LVAcheer.com). The entire form must be turned in to the coach prior to missing practice.

NOTE: Parents, please try to refrain from keeping athletes from practice as a punishment as this only hurts the team as a whole. If an issue arises please communicate with the coach.

Competition season may become hectic which may lead to extended or additional practice times. This is to ensure all athletes are completely ready to perform. We ask that you try your hardest to work with us during these times as we are doing it to better the performance value.

Please keep in mind that missing any practice within TWO WEEKS of an upcoming competition will amount in a \$65 fine.

#### ACCEPTABLE examples to miss practice

- Severe Illness
- Immediate Family Emergency
- Mandatory school function with prior approval from the coach

#### UNACCEPTABLE examples to miss practice

- No ride
- Tired/Headache/bad day at school
- Too much homework
- Prior commitment (ex: hanging with friends, mall trips, etc.)

## COMPETITIONS

Attendance at all competitions is mandatory by all team members. If there is an EXTREME EMERGENCY that will cause your athlete to miss a competition, please let the coach know immediately so that necessary measures can be taken to re-arrange the routine and prepare the remaining athletes to compete.

Practice 2 weeks before a competition is MANDATORY. NO EXCUSES.

- o If a practice is missed within the 2 weeks before a competition without getting the coaches approval beforehand, a fine of \$65 will be charged to the athlete's account.

Competition fees are non-refundable.

- o Whether or not your child competes

Each child and parent is required to maintain good behavior and a level of respect towards all other teams.

- o Derogatory statements or negative behavior made toward the competition or another team will not be tolerated.
- o You may be asked to leave and subject to suspension or dismissal.

Missing a competition without prior approval will be grounds for dismissal.

Your child may be removed from a competition for any of the following reasons.

- o Attendance, Finances, Injury or Attitude

Members need to be appropriately dressed at all competitions (when they arrive and during award ceremony.)

- o Uniform Top/Bottom/Bow (warm ups worn or brought with)
- o NO stomach showing for ANY athletes. Stomach must be covered when not on the performance floor.
- o White "no show" socks
- o Competition Shoes
- o Hair and Makeup done according to coach's previous directions.
- o NO JEWELRY
- o NO COLORED NAIL POLISH (Acrylic Nails in team colors ONLY)

## SAFETY

- We will provide the safest environment possible for all children; however All Star Cheerleading is a contact sport. With that being said, neither we nor the gym are responsible for any injury that your child may receive while in our care.
- No unsupervised tumbling or stunting before, during or after practice on premises.
- No candy or gum allowed in gym at any time unless brought by the coaches as a reward for the team.
- Proper attire is mandatory.

## SCHOOL AND GRADES

We understand that school is important and we encourage it to be made a priority. Please manage your time accordingly and try to complete any homework assignments prior to any practice times.

Show your coach your STRAIGHT A report card and receive a FREE 30 minute private lesson!

## SOCIAL MEDIA

As mentioned previously, you are a representation of LAS VEGAS ALL STARS. Any ill intended posting or malice towards teammates, coaches, parents or other teams on any social media site will not be tolerated. Please be mindful that the public can see any and every social media posting.

## Parent Expectations

- Challenging the coach or person in charge by a parent will be automatic dismissal.
- Negative Behavior will not be tolerated.
- To make sure your child is on time and ready for practice on designated practice times.
- Parents are to inform the coach if their child is going to be late or miss practice. Sometimes the children forget such important information as this.
- Parents are to fulfill any financial obligations ON TIME or risk expulsion from our team.
- Parents are to support their children and their children's goals.
- Parents are to hold children accountable for their actions. If there is an issue, encourage your child to talk to the coach, this only enforces and gives your child a sense of being heard and understood.
- Other arrangements need to be made if a parent cannot stay for the duration of the competition with another LVA Family.
- Support the rules and encourage your child to abide by them.
- Parents are to support our coaches. Our coaches have your child's best interest and safety in mind at all times.
- Parents are to stay off the practice mat at ALL TIMES. Unless otherwise stated by the Head coach.
- There will be NO outbursts by the parents tolerated whatsoever. Grounds for dismissal.
- If a parent or child decides to leave the team for any reason before the season is over (May 16, 2023) the parent is responsible for paying a buyout fee of \$500 and the remaining monthly tuition in full at time of departure.

## Athlete Expectations

- I will be on time to practice and dressed appropriately.
- I promise to give 100% at every practice.
- I will not say "I Can't".
- I will do my personal best to achieve all my goals.
  - o Continual failure to be productive at practice will result in disciplinary action which is subject but not limited to suspension or dismissal. (Talking back, lack of motivation, etc.)
- I am responsible for finding out any information I may have missed.
  - o My parent is not responsible for any assignments my coach gives me.
- I will maintain the highest example of behavior.
- I will respect each other's personal space.
- **BULLYING (physical or verbal) will not be tolerated.**
- I will come to class ready to work and ready to listen to my coaches.
- I am aware of the commitment I will be giving to join a competitive team.
- I am aware of the responsibilities I am taking on by joining a competitive team.
- I am willing to be cooperative and helpful to the coach or any person in charge at all times.
- I am willing to work hard and give 100% at all times.

# Financial Agreement

1. Fees All payments are subject to the fee schedules listed below in 2.1 and 2.2. No athlete will be permitted to compete with an overdue balance. In addition, you will be assessed a \$25 late fee each month that your payment is made more than five (5) days after the due date. In addition, you will be assessed a \$65 late fee if your child misses practice within one week of a competition without prior approval by coach. In addition, you will be assessed a \$65 late fee if your child is late to “Coach Collect Time.”

2. Non Refundable. Any and all fees are not refundable once paid. By signing this contract, you have agreed to be fully responsible for all fees, including without limitation, tuition, competition, equipment, and clothing fees, regardless of whether your gymnast competes or not for any reason; including without limitation, injuries, suspension or dismissal, withdrawal from the team, and/ or dissatisfaction with services.

2.1 Competition Fees. Cheer Expenses/Competition Fees are \$401/month for Returning Athletes, and \$470/month for New Elite Athletes from June 5<sup>th</sup> 2022 until March 1<sup>st</sup>, 2023.
